**PROPOSED AMENDMENT NO. 3 TO AGREEMENT 400-2025 WITH CALIFORNIA MENTAL HEALTH SERVICES
AUTHORITY TO EXTEND THE TERM OF THE AGREEMENT
(Fiscal Impact: NONE)**

Behavioral Health and Recovery Services (BHRS) requests the Board's approval of Amendment No. 3 to Agreement 400-2025 with California Mental Health Services Authority (CalMHSA) providing support in managing administrative and reporting requirements associated with the Commission for Behavioral Health (CBH) approved Innovation (INN) funds for the participation in CalMHSA's Semi-Statewide Enterprise Health Record program to extend the term of the agreement through March 30, 2027. There is no fiscal impact associated with this request.

Agreement 400-2025 signed on July 29, 2025, provided support in managing administrative and reporting requirements associated with the Commission for Behavioral Health (CBH) approved Innovation (INN) funds for the participation in CalMHSA's Semi-Statewide Enterprise Health Record program from July 15, 2025, through December 31, 2025.

Agreement 570-2025 served as Amendment No. 1 signed on November 18, 2025, to extend the term of the Agreement from July 29, 2025, through June 30, 2026.

Agreement 153-2026 served as Amendment No. 2 signed on April 28, 2026, extend the term of the agreement through September 30, 2026, update funding limits, revise program description details, and add options for the county to purchase Power BI user licenses to support enhanced analytics dashboard by increasing compensation to the contractor by \$2,400.

Proposed Amendment No. 3 seeks to extend the Term of the agreement through March 30, 2027, at no additional cost to the department.

This Amendment No. 3 has been reviewed and approved as to form by County Counsel.

Therefore, IT IS RECOMMENDED that the Board approve Amendment No. 3 to Agreement 400-2025 with the California Mental Health Services Authority to extend the term of the agreement through March 30, 2027, and authorize the Chairman to sign.

PARTICIPATION AGREEMENT AMENDMENT NO. 3
QA/QI Analytics Program ("Program")

This Agreement Amendment No. 3 ("Amendment No. 3") amends Agreement No. 11572-KC-QAQI-25_26 ("Agreement") and subsequent Amendments ("Amendment"), a contract entered into by and between the California Mental Health Service Authority ("CalMHSA") and Kern County ("Participant") on November 18, 2025. This Amendment shall be effective upon execution by both parties.

This Amendment No. 3 hereby amends the Agreement to extend the Term through March 30, 2027 at no additional cost to Participant as described below.

Modifications to Agreement:

1. **Modified Term:** This Amendment No. 3 extends the Term of Program Offerings Nos. 1 – Policies through March 30, 2027 at no additional cost to Participant. The revised Term shall be January 1, 2025, through March 30, 2027.

All other terms or provisions in the Agreement not amended by Amendment No. 3 shall remain in full force and effect.
