Tracking consists of monitoring all Grand Jury reports and complaints which includes the Grand Jury, County Counsel and the Presiding Judge. The Recording Secretary follows the report responses received from cities, agencies and departments of Kern County. When responses are required, agencies or organizations must reply to the Presiding Judge of the Superior Court within a designated time period. Tracking also ensures the subjects of all Grand Jury reports are duly noted and all recommendations are acknowledged to assure that Penal Code §§933 and 933.05 are followed.
